## ASP2023 Health and Safety Policies

Participants acknowledge that COVID-19 is an infectious virus that spreads easily through person to person contact and may cause serious illness to individuals who are unvaccinated and or have certain medical risk factors. Federal and state public health authorities have issued basic health and safety guidelines aimed at mitigating the spread of the virus. Participants understand attending ASP2023 may increase the risk of contracting COVID-19. ASP in no way warrants that the protective measures prescribed for ASP 2023 conference will completely prevent exposure to the COVID-19 virus. Participants agree to follow all public health and safety guidelines to attend ASP2023 and acknowledge the risk of potential COVID-19 exposure and infection during the meeting.

Because of the COVID-19 pandemic, local conditions and safety guidelines are constantly evolving. We are closely monitoring the current state, federal and local COVID-19 guidelines for in person gatherings and travel restrictions. As of May 2023, the US is no longer under a state of emergency regarding COVID-19 and travel restrictions and mask mandates have been lifted. ASP asks that 2023 ASP Annual Meeting participants who test positive for COVID-19 after arriving in Rockville, MD, who do not feel well, or who are experiencing any COVID-19 symptoms at any point during the meeting refrain from attending the meeting or participating in any in-person meeting-related activities.
